State Fiscal Stabilization Funds

The State Fiscal Stabilization Fund provides \$53.6 billion to provide fiscal relief to states. Montana will receive \$148,689,792 in stabilization funds.

Description:	To provide fiscal relief to the states to prevent tax increases and cutbacks in critical education and other services. To provide funding for elementary, secondary, and higher education, and for public safety and other government services, including higher education modernization. *\$540 million was included for Vocational Rehabilitation State Grants.
Montana will receive \$1.9 million in funding.*

Description:	This program provides grants to states to support a wide range of services. Eligible individuals are those who have a physical or mental impairment that results in a substantial impediment to employment, who can benefit from vocational rehabilitation (VR) services for employment, and who require VR services. Priority must be given to serving individuals with the most significant disabilities if a state is unable to serve all eligible individuals.

\$100 million was included for the Teacher Quality State Grants program.

- Description:** To provide grants to states to improve the quality of the teaching workforce. States may use grant funds to reform teacher licensing and certification requirements; provide alternative methods of teacher preparation; and provide alternative routes to state certification. Renewable Energy Incentives

Long term extension and modification of renewable energy production tax credit.

Description:	The bill extends the placed-in-service date for wind facilities for three years (through December 31, 2012). The bill would also extend the placed-in-service date for three years (through December 31, 2013) for certain other qualifying facilities: closed-loop biomass; open-loop biomass; geothermal; small irrigation; hydropower; landfill gas; waste-to-energy; and marine renewable facilities.

Investment Tax Credit

Temporary election to claim the investment tax credit in lieu of the production tax.

Agency:	U.S. Department of Treasury
Description:	Under current law, facilities that produce electricity from solar facilities are eligible to take a thirty percent investment tax credit in the year that the facility is placed in service. Facilities that produce electricity from wind, closed-loop biomass, open-loop biomass, geothermal, small irrigation, hydropower, landfill gas, waste-to-energy, and marine renewable facilities are eligible for a production tax credit. Because of current market conditions, it is difficult for many renewable projects to find financing due to the uncertain future tax positions of potential investors in these projects. The bill would allow facilities to elect to claim the investment tax credit in lieu of the production tax credit.

Weatherization Assistance Program

\$5 billion was included for the Weatherization Assistance Program. Provisions also expand the eligibility of low-income households for the Weatherization Assistance Program and increasing the funding assistance level per dwelling (from \$2,500 per dwelling to \$6,500).

Energy Efficiency and Conservation Block Grant (EECBG)

\$3.2 billion was included for EECBG, of that over \$2.7 billion will be distributed for formula grants.

Montana will receive \$13.971 million.

Agency: Department of Environmental Quality

Description: To reduce fossil fuel emissions, decrease overall energy consumption, improve energy efficiency in the transportation, building, and other energy consuming sectors of the economies of eligible entities. Assists states and local governments in implementing strategies to reduce fossil fuel emissions created as a result of activities within the jurisdictions of the eligible entities and reduce the total energy use. Activities eligible to receive funding include: conducting residential and commercial building energy audits; establishing financial incentives programs for energy efficiency improvements; grants to non-profit organizations to perform energy efficiency retrofits; developing/implementing programs to conserve energy used in transportation; developing and implementing building codes and inspections services to promote building energy efficiency; installing light emitting diodes (LEDs); and developing, implementing, and installing on or in any government building onsite renewable energy technology that generates electricity from renewable sources.

Consumer Tax Incentives for Alternative Vehicles

You can get an income tax credit of \$250 to \$3,400 for buying or leasing a new hybrid gas-electric or diesel automobile. Hybrid vehicles are those that use less gasoline than the average vehicle of similar weight and that meet an emissions standard. "Lean-burn" diesel vehicles also qualify, but only a few diesel models meet the emissions standard. A similar credit exists for plug-in hybrid or pure electric vehicles, alternative-fuel vehicles and fuel-cell vehicles. The American Recovery and Reinvestment Act of 2009 provides \$2 billion in consumer tax credits for plug-in electric vehicles, by modifying and increasing a tax credit passed into law in 2008. The bill also restores and updates the electric vehicle credit for plug-in electric vehicles that would not otherwise qualify for the larger plug-in electric drive vehicle credit, and provides a tax credit for plug-in electric drive conversion kits.

COBRA Continuation Coverage

\$24.7 billion was included for COBRA Continuation Coverage.

It provides a special 60-day election period for a qualified beneficiary who is eligible for a subsidized premium and who has not elected COBRA continuation coverage as of the date of enactment or who is no longer enrolled on the date of enactment, for example, because the beneficiary was unable to continue paying the premium. Recession-related job loss threatens health coverage for many families. This provision is intended to provide targeted assistance to individuals and families who have been involuntarily terminated to enable them to afford premium payments for health insurance coverage under COBRA. The Joint Committee on Taxation estimates that this provision would help 7 million people maintain their health insurance by providing a vital bridge for workers who have been forced out of their jobs in this recession.
